\$25 APPLICATION FEE WAIVED

The Texas Tuition Promise Fund® (TTPF) turns 15 years old in September! We are celebrating by waiving the \$25 application fee for all new enrollments in September and October 2023. Enrollments by mail must be postmarked by Oct. 31, 2023, to take advantage of the waiver.

The TTPF General Enrollment period begins Sept. 1, 2023, and ends Feb. 29, 2024. Yes, that's right – you will have an extra day on Leap Day in 2024 to enroll. Newborn Enrollment for children younger than one year of age extends



through July 31, 2024. Enroll online, or download or order an enrollment kit, at TuitionPromise.org.*

HISTORY OF THE PLAN



As of July 31, 2023, the plan had \$1.2 billion in assets, 50,773 enrollments and had sold 8.9 million tuition units.

This year marks the 15th birthday of the Texas Tuition Promise Fund. We're happy to have helped thousands of families plan for higher education since the plan first opened for enrollment in 2008.

The 80th Texas Legislature established the Texas Tomorrow Fund II in 2007. The plan is an IRC Sec. 529 prepaid tuition plan marketed as the Texas Tuition Promise Fund (TTPF) and administered by the Texas Prepaid Higher Education Tuition Board chaired by Comptroller Glenn Hegar. An additional six board members are appointed by the Governor (2)

and Lieutenant Governor (4). Board members must possess knowledge, skill and experience in higher education, business or finance.

As of July 31, 2023, the plan had \$1.2 billion in assets, 50,773 enrollments and had sold 8.9 million tuition units. The tuition units can be redeemed in the future for hours at Texas public colleges and universities. These schools must accept the tuition units as payment in full for tuition and schoolwide required fees for the number of hours covered by the plan. The plan can also be used at Texas medical and dental



schools, Texas private colleges and universities, out-of-state colleges and universities, career schools and registered apprenticeship programs by converting the tuition units to Transfer Value. This value is limited to the lesser of (1) the costs the tuition units would cover at a Texas public college or university, or (2) the original purchase price of the tuition units plus or minus the plan's net investment earnings or losses on that amount.

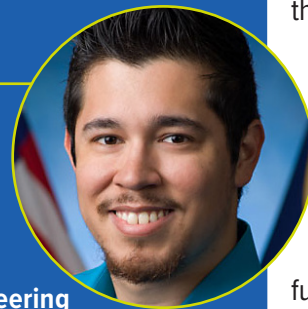

WHAT'S NEW WITH TTPF?

The Texas Tuition Promise Fund transitioned to a new customer access portal last year. The new portal makes it easier than ever for participants to manage their accounts online and includes a number of enhanced features:

- A modern new look with a mobile-friendly, easy-to-navigate design
- Enhanced account contribution features for one-time and recurring contributions
- The ability to upload documents online

- A streamlined process for authorizing tuition unit redemption online
- A financial history tool that includes filtering and downloading features

If you established online access before we transitioned to the new portal on Oct. 31, 2022, you will need to re-register before accessing your account. Make your transition easy with the simple steps below:

- Log in to your account at access.textastuitionpromise.com/login.

- Click on Register for Online Access on the right-hand side of the screen.
- Have your Social Security Number and either your account number or your beneficiary's date of birth available.

Your USER ID will become your email once you re-register on the new platform. Your account number will remain the same.

ENHANCED PAYMENT FEATURES

It's easy to contribute to your account online in the new portal. You have the option to make a one-time contribution or set up automatic payments for your loved one's Installment or Pay-As-You-Go account. Once you have registered and logged in to your account:

TO MAKE A ONE-TIME CONTRIBUTION –

- Click on the **Financials** tab
- Select **One-Time Payment**
- Enter a **Payment Amount** (minimum contribution of \$15)
- **Select Your Bank** (or **Add New Bank Information**)
- Click **Next** and follow the remaining instructions

TO SET UP AUTOMATIC PAYMENTS –

- Click on the **Financials** tab
- Select **Automatic Payments** and then **Add Automatic Payments**
- Enter a **Debit Amount** (minimum contribution of \$15)
- **Select Bank Account****
- Click **Review** and follow the remaining instructions

Scholarship Opportunities

Your loved one could be eligible for a unique scholarship opportunity!

The Texas Match the Promise FoundationSM offers matching scholarships and grants to eligible third through ninth graders who are Texas Tuition Promise Fund (TTPF) beneficiaries and whose families have an adjusted gross income of \$100,000 or less. The scholarships and grants are awarded in the form of TTPF tuition units.

Approved recipients can receive matching scholarships of tuition units worth up to \$2,000 at today's prices. Top-scoring recipients can also receive a one-time grant of tuition units worth \$3,000 at today's prices.

The Foundation accepts scholarship applications **Sept. 1 through Dec. 31**. Applicants can apply online or download an application form to mail in. Families may enroll in TTPF during the scholarship application period if they haven't already done so.

Match the Promise is funded by generous contributions from citizens, building a stronger Texas for tomorrow, and has awarded more than 700 scholarships and grants.
